- 5. Was petitioning preceded by attempts to bring consensus, such as:
 - sending letters, signing traditional petitions
 - meetings with opponents and policy makers
 - mediation, trilateral meetings
- 6. Whom were they aimed at?
 - a. opponents

- 7. What was the result of those attempts?
- 8. Was petitioning preceded by forms of gaining support, such as:
 - interviews, reports in media
 - asking experts and authorities for support

- 10. Was petitioning precede by any direct actions, such as:
 - picketing, happenings

- 20. Writing the petition, were you in contact with local or regional government?
- 21. Which member(s) of your organizations engaged the most in writing and monitoring the petition? Was it one person or more?
- 22. Did you engage in writing and monitoring the petition? Why/why not?
- 23. Have there been any actions accompanying the petition, such as:
 - contacting the European Parliament Commission, monitoring the petition
 - sending additional materials to the Commission
 - information about the petition sent to politicians, media, public opinion through social networking
 - organizing conferences, seminars
 - other actions.
- 24. Do you find those actions sufficient? In your opinion, could anything else have been done?
- 25. Did you know about the opportunity of online petitioning (through the petition site, such as gopetition.com)? Did you write such a petition? Why / why not?
